On Wednesday, November 14, 2018, bathroom inspections of South Orange Middle School, South Mountain, South Mountain Annex, Marshall, and Montrose schools were conducted. There were no hygiene issues or odors detected. Paper and soap dispensers were filled with supplies and working, the water temperature was measured in all of the bathrooms. Some ceiling tiles and light covers were missing. Some faucets were not functioning but there was running water in all bathrooms. Evidence of vandalism, such as scratching off fresh painted areas and wall damage was present. Findings are presented below.

- Visible damage to stall walls (vandalism)



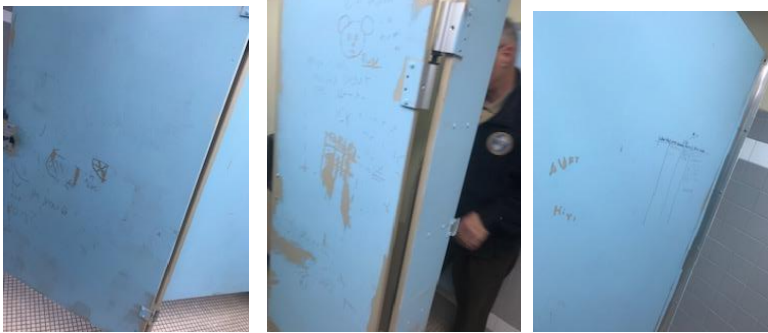
3rd Floor Boys Bathroom

- Ceramic tiles missing from wall
- Ceiling tiles damaged by throwing wet papers onto ceiling.
