## **ORDINANCE #2024-19**

**Introduction: September 9, 2024**

**Adoption:**

**AN ORDINANCE TO AMEND THE CODE OF SOUTH ORANGE VILLAGE, SECTION 340-22 WITH RESPECT TO LOADING AND UNLOADING ON IRVINGTON AVENUE.**

**BE IT ORDAINED**, by the Village Council of South Orange Village, a municipal corporation of New Jersey located in Essex County thereof, as follows:

### **SECTION 1.**

The Code of South Orange Village, Section 340-22 – Loading Zones, is hereby amended by the addition of the following:

<b>Name of Street</b>	<b>Side</b>	<b>Location</b>
Irvington Avenue	Southwesterly	Commencing 193 feet northwesterly of its intersection with the northwesterly curb line of West Fairview Avenue and continuing northwesterly for an additional 46 feet.

### **SECTION 2.**

This ordinance shall take effect upon final passage and publication as required by law.

### **SECTION 3.**

On passage this ordinance shall be codified.
