ORDINANCE #2025-06

Introduction: February 24, 2025

Adoption:

AN ORDINANCE APPROPRIATING \$120,000.00 IN THE GENERAL CAPITAL FUND FOR THE UNDERTAKING OF RENOVATIONS TO AND FURNISHINGS FOR THE MUNICIPAL BUILDING

BE IT ORDAINED by the Mayor and Council of South Orange Village, County of Essex and State of New Jersey, as follows:

SECTION 1. The construction of a children's garden at the South Orange public library as described in Section 2 of this ordinance is hereby authorized by South Orange Village, and, there is hereby appropriated the sum of \$120,000.00 of which \$120,000.00 is from a contribution from The Foundation for the South Orange Public Library

SECTION 2. The appropriation is authorized for the construction of a children's garden at the South Orange public library, including but not limited to the following:

- a. Patio and seating area(s)
- b. "Green" area(s) for planting
- c. Any other outdoor space to facilitate children's educational activities

SECTION 3. The appropriation shall be made from a contribution received The Foundation for the South Orange Public Library and no debt is authorized.

SECTION 4. This ordinance shall take effect immediately after the first publication after final passage as provided by law.

SECTION 5. On passage this ordinance shall NOT be codified.
