CALENDAR YEAR 2020 ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK (N.J.S.A. 40A: 4-45.14)

## **ORDINANCE SUMMARY FOR PUBLICATION**

This Ordinance authorizes the Village to appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years. The Board of Trustees of the Township of South Orange Village in the County of Essex finds it advisable and necessary to increase its CY 2020 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens. The Board of Trustees further determines that a 1.0 % increase in the budget for said year, amounting to \$275,592.52 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary. The Board further concurs, that, in the CY 2020 budget year, the final appropriations of the Township of South Orange Village shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by 3.5%, amounting to \$964,572.88, and that the CY 2020 municipal budget for the Township of South Orange Village be approved and adopted in accordance with this ordinance. Lastly, the Board of Trustees determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.
