RESOLUTION AWARDING A CONTRACT TO RIO FOR THE PURCHASE OF ADVANCED METERING INFRASTRUCTURE (AMI) RELATED EQUIPMENT IN THE AMOUNT NOT TO EXCEED \$100,000

WHEREAS, the Township of South Orange Village (the "Village") has a need to purchase water meter data collection communication hardware for support of the implementation of an AMI system

WHEREAS, RIO Supply, Inc., 100 Allied Pkwy, Sicklerville, NJ 08081 has been awarded Contract #47 from the Morris County Cooperative Purchasing Council (MCCPC) for Water Meters/Data Recorders & Radio Frequency Meter Interface Units.

WHEREAS, the Village Administrator has recommended the acquisition and installation of Radio Communication equipment and related items

THEREFORE, BE IT RESOLVED by the Board of Trustees of the Township of South Orange Village that the Village hereby authorizes and approves the purchase of:

BE IT FURTHER RESOLVED that the Village Clerk shall confirm with the Board of Trustees when the certification of available funds has been received by the Village's Treasurer and contract terms and conditions have been approved by Village Counsel.
